TERMS AND CONDITIONS

- Tender should be submitted inclusive of all taxes, duties, charges for delivery at State Family Welfare Bureau, Directorate of Health Services, Campal-Panaji Goa.
- Tender should be signed by authorized persons with date and seal of the company.
- Tender should be valid for 1 year from the date of placement of order.
- The tenderer should deliver the goods within a period of eight working days from the receipt of the firm order, failing which the order will be treated as cancelled without further notice.
- The supplier may insure the goods at his own cost to safeguard the delivery of the goods dispatched to him by the consignee as the department will not be responsible for the damage or pilferage of goods during transit.
- The bill should be furnished in quadruplicate with the revenue stamp. The stock should be supplied at the destination mentioned in the order.
- The Tenderer shall be liable for the payment of penalty @10% of tender value per week of delayed period as liquidated damages to the Department. The day will be reckoned at the end of working hours.
