2. **Tender document may be collected from this office by paying Rs.200/- or you can download the bid document from [www.nhm.goa.gov.in](http://www.nhm.goa.gov.in) website and document fee i.e. Rs.200/- may be submitted along with the tender envelope.**
3. Tender should be valid for 1 year from the date of work order.
4. Canvassing in connection with quotations is strictly prohibited and any other tender submitted by the party who resorts to canvassing will be liable for rejection.
5. Overwriting and corrections are not accepted in the complete tender. However, if found unavoidable, such overwriting, correction shall be properly attested by the Competent Authority.
6. The acceptance or rejection of the quotation depending upon their appropriation will be decided by the Competent Authority only on detailed scrutiny.

7. The Vice Chairman, State Health Society (NRHM), Directorate of Health Services, reserves the right to accept/ reject any tender in part or whole without assigning any reasons thereof. His/ her decision on the dispute in any way will be final.
8. In the event of an order being placed with against the quotation and failure to complete job in accordance with the terms and conditions, the Vice Chairman, State Health Society (NRHM), Directorate of Health Services, shall be entitled to issue order from other party as the Competent Authority shall at the sole discretion think fit.

Any dispute or difference whatsoever arising between the parties, out of or relating to the conclusions, meaning and operation or effect of the agreement or the breach thereof shall be settled by Arbitrator in accordance to the Rules of Arbitration of the Indian Government of the Arbitration and the amount made in pursuance thereby shall be binding on the parties.
10. Conditional offers are liable to be rejected.
11. The Department will not make any advance payment. Income Tax etc. will be deducted at Source (TDS) from the final bills as required under I.T. Act.
